- 4. Ongoing Business:
 - a. Road Engineer Update-Flood Damage Repair: The Board reviewed with Road Committee member Mark Rawlings the revised and more defined proposal from KC Cement. The Board agreed that all questions had been fully answered in their current agreement. The motion was made and carried 4/0 to proceed with KC Cement for the repair of bridges 1& 2 on Ruby Ranch Rd. and the bridge on Clark Cove.

 - a. Flag Replacement at RR Entrance-Update: Mark Rawlings replaced the existing damaged flag. He insured that the old flag was properly handled and disposed. Crack Seal will begin12/18 weather permitting. Thank you to Ramming Paving for their support in funding and completing this project.
 - b. Road Committee Ant Control-Update: Ramming crack seal project should help with the ant problem. We will contact them as well to see if they suggest an additional solution.
 - c. Annual Meeting
 - * Discuss date and place of meeting-Update: David has confirmed the meeting will be held at the Ruby Ranch Lodge on February the 24th. Madelyn Uresti ,the Lodge Owner, has graciously offered the use of her facility to hold our annual meeting. The Lodge will hold approximately 125 people, which should be sufficient based on past attendance.
 - * Develop specific election rules as needed-Update: Scott will send out last year's rules for the Board to review. Lewis Jones, a RR resident and Attorney, has volunteered to review the rules to make sure they follow this years current State Law.
 - * Activate Nominating Committee-Update: The Board confirmed the Nominating Committee will again this year complete the vetting process for all applicants interested in running for the RR Board of Directors. Scott will forward all applications to the committee for review.

The vote counting process must be done by an "outside of the community" volunteer. Cristi will work on finding and qualifying that person or persons.

d. Review/Discuss top 3 ACC Violations: ACC asking for the ability to asses fines for non resolution by home owner-Update: Kevin Ritchie, ACC Lead person, will present the proposed program to deal with <u>only one</u> of the CCR violations, 8.17 which states: Trucks, Buses, Boats, Campers, Recreational Vehicles and Trailers. No vehicle of any kind shall be left parked in the street in front of any Lot, except for construction and repair equipment while a residence or residences are being built or repaired In the immediate vicinity. No truck (except for pick-up trucks), bus (except a passenger van for personal use), boat, camper, recreational vehicle, trailer, disabled or unregistered vehicle shall be parked on the driveway or any portion of the Lot. in such manner as to be visible from the street.

Kevin will outline the proposed specific procedure leading up to the option to issue a fine. To include this option there will have to be a special meeting and community vote to change the existing Bylaws.

Traffic Coordinator: This position will be dissolved since it has not been active for several years.

The Bookeeping RFP and Mowing RFP will be posted on the website. There will be a time period of 30 days to respond. Anyone who wants to apply and is qualified should go to the RR Website and download the RFP. David will also send out RFP's to known Mowing companies that may want to participate in providing pricing.

It was suggested that Ruby Ranch should have a "Welcome Letter" that could be sent out to all new residents. This would contain valuable information for new residents. Cristi will head up that program.

The Board again agreed to have the Sherriff's Department patrol RR Roads in December.
