- b. PEC/Verizon Broken PVC Pipe Update Verizon still has not repaired or replaced the broken PVC pipe that is visible at the Clark Cove Bridge. Kevin and Thomas will both follow up to get the repair finalized.
- c. Reflectors for Bridges and Culverts
 The contract to update and replace the reflectors has been awarded and we are in their work schedule. Work should begin within 30 days.
- d. Roadway Weed Control
 - Weed control work has been scheduled and should begin soon.
- e. Road Repair and or Overlay
 - The motion was made to have James get final numbers broken out to repair and overlay the section of RR Road from the bridge to Humphreys and also all of Humphreys Road. Based on the numbers, Asphalt Paving has the lowest price and will be awarded the work if the breakout numbers track to their previous proposal.

- d. Discussion CCR, Bylaws, Leon Breeden, Legal Documents Now that the CCR and Bylaw votes are certified Leon will generate 3 documents to complete the process. 1). Unanimous Consent letter 2).Certification Letter on Bylaws stating that a Quorum of 164 lot owners was present and the vote to change was more than 50%. 3). Certification Letter that states the vote for changing the CCR's was approved by more than 75% of the RR lot owners. The Bylaws will then need to be updated with the new language and posted on the website.
